- Participants must be at least six or in the first grade to use the wall and demonstrate to the wall operator's satisfaction that they are able and willing to follow the safety and use instructions.
- Participants must complete a Climbing Consent Form to climb. People under the age of 18 must have the form signed by a legal parent or guardian. If guardianship is separated, the form must be signed by both legal guardians.
- The \$200 deposit is non-refundable. If the renting organization cancels use less than three months prior to the date of the reservation, the \$200 deposit is non-refundable; cancellations prior to 3 months of the reservation may be eligible to reapply the deposit to a new reservation.
